### WILL OUR NATION TURN BACK TO GOD?

As a nation, we are at a crossroads. Our secularized culture has literally shaken its fist in God's face and rejected His very name. We have become an abomination before God. The Prophet Jeremiah warned the Judeans of impending Babylonian captivity. He repeatedly reminded them that their exile would take place because they had forgotten God (Jeremiah 2:32; 3:21; 13:25; 18:15).

Every day I received email messages about what is happening in Washington DC and the impact it is having on our lives and our families. I have also received articles through email and various other media which indicate to me that God is giving us warnings as a nation. We have been prosperous and a world leader for a long time, but these past four years have revealed our dependency on our *own* wisdom and our *own* strength. They have shown us the gods that are in our lives, such as Wall Street, our financial portfolios, greed, pride, power, and control ("reproductive freedom").

Recently, President Clinton said that President Obama "has a plan to rebuild America from the ground up." [Source: Decision, October 2012] When I think of the word "rebuild," I think of creating something new – like rebuilding a house from the ground up after a fire has destroyed the original structure. Rather than "rebuild," however, we must restore –

that is, we must "restore" godly principles upon which this nation was founded and for which our forefathers shed their blood. It is because we have been governed by a Constitution which was written with these godly principles in mind that God's blessing has been upon our nation for the past 236 years. But what lies ahead? Will God remove His blessing from America because we have turned our back on Him?

It is time for the American people to heed the warnings that the Lord is giving through many means and stand up for clear Biblical standards and for our freedom to live by those standards. Like Daniel and his three friends, Shadrach, Meshach, and Abednego, we cannot compromise our deeply held convictions about whom we worship. And as Peter and the other apostles in Acts 5, we need to obey God rather than men when government clashes with our obedience to God. An example lies in the fact that though Roe vs. Wade made abortion legal, our obedience to God tells us to stop the killing of innocent children. Most recently, regarding Obamacare, government tells us to provide women with abortifacients and surgical abortions with our tax dollars. In God's eyes, will our compliance to government rather than obedience to the Lord make us accomplices in the deaths of preborns? How long before the all-powerful and just God retaliates for the sinful direction our nation has taken?

There are things we can, and must, do. Christians need to carefully research the candidates and the principles upon which they stand, not only at the national level, but also at the state and local levels. We must also remember that no matter who is elected at each level of government, difficult times are ahead. Much systemic damage has been done these past four years and it will not be easily corrected. However, the first step is to elect candidates at all levels who will restore America back to godly principles, including the protection of innocent human life. Otherwise, along with the financial ruin that will surely come, a loss of freedoms, like no one can imagine, could lie ahead.

Once we have elected righteous men and women to office, we cannot expect them to handle their position seriously if we do not support them in prayer as commanded in I Timothy 2:1-4. Very likely, elected officials with strong spiritual foundations have already gone to Washington, but without our prayers, have faltered when faced with the lions of government.

Yes, it is a crucial time in our nation. Will we heed the warnings and turn back to God and His principles or will we continue to reject God and thus lose His blessing upon our land?

## EDUCATIONAL OUTREACH

**Students for Life of America Conference 2013:** The Teachers Saving Children® Inc. – National Board of Trustees officially approved sponsorship of an exhibit table at the Students for Life of America Conference (SFLA), to be held on Saturday, January 26, 2013, in Bethesda MD. The cost is \$1000, which includes 2 passes to the conference for our volunteers overseeing the exhibit. We have a means to transport the exhibit to the conference site without expense. However, we will need to meet travel costs for our two volunteers. This sponsorship is a golden opportunity to reach 2,000 high school and college students with information about Teachers Saving Children® and to provide those going into education with options regarding union membership.

**NEA Expo 2013:** The Board of Trustees officially approved submitting an application for a Teachers Saving Children® exhibit at the NEA Expo 2013, to be held in Atlanta GA July 1-3, 2013. By submitting an application with a \$50 deposit in September, Teachers Saving Children® will be able to pay the same exhibit fee of \$1400 as last year under the condition that we pay the balance by February 1<sup>st</sup>. In addition, by submitting an early application, we are also able to secure a particular booth location which will provide Teachers Saving Children® with greater visibility to educators attending the Expo.

**Our Financial Need:** Our Educational Outreach fund is currently at a deficit. The sponsorship fee is paid for the SFLA Conference and the deposit is paid for the NEA Expo. ## MARCH FOR LIFE FOUNDER NELLIE GRAY PASSES AWAY

LifeNews.com reported on August 14, 2012 that Nellie Gray, founder of the March for Life, and a tireless pro-life advocate for decades, passed away. The article quoted several pro-life figures who spoke highly of Nellie Gray's dedication to the sanctity of life. Father Frank Pavone, National Director of Priests for Life, stated, "Every year since 1974, Nellie Gray has mobilized a diverse and energetic army for life. Her own commitment to the cause never wavered. She was a tireless warrior for the unborn and her motto was 'no exceptions.' As a colleague in national pro-life leadership, Nellie was always an inspiration to the rest of us." Every year since its founding in 2003, Nellie Gray invited the women of the Silent No More Awareness Campaign to stand on the rally stage holding signs that said, "I Regret My Abortion." Janet Morana, Executive Director of Priests for Life and co-founder of Silent No More stated, "We are so grateful that Nellie Gray shared our vision of Silent No More, and recognized that the women who have had abortions speak with the unquestioned authority about the ways they have been harmed by this choice." Gray is also credited with realizing that African-American pro-life leaders had to become more vocal and visible in the fight for life. Dr. Alveda King, director of African-American Outreach for Priests for Life, stated, "Nellie Gray knew that abortion took a heavy toll from the black community and she urged us to lend our voices to the fight against this terrible injustice."

The 2013 March for Life will mark the 40<sup>th</sup> anniversary of the Supreme Court's Roe vs Wade decision, and the 39<sup>th</sup> anniversary of the March. "It was an anniversary that broke Nellie Gray's heart every year, and every day," Father Pavone noted. "In January we will march in her memory, in her honor, to save the unborn children to whom she dedicated her life."
