## THOUGHTS FROM THE EXECUTIVE DIRECTOR

*"I urge, then, first of all, that requests, prayers, intercession and thanksgiving be made for everyone – for kings and all those in authority, that we may live peaceful and quiet lives in all godliness and holiness. This is good, and pleases God our Savior."*  
-I Timothy 2:1-3

The National Day of Prayer events are held annually on the first Thursday of May. As I was preparing a devotional for a prayer group, I began to reflect and read through several different pamphlets and brochures that I have on praying for those in authority. As often as I receive emails and other communiqués regarding the direction our nation's leadership is taking this country, I believe that the most active means of making a difference in our nation and in the world is through prayer. J. Sildow Baxter said, *"Men may spurn our appeals, reject our message, oppose our arguments, despise our persons, but they are helpless against our prayers."* (Source: National Day of Prayer Bookmark).

The Bible instructs us to offer prayers for those who are in authority so that we may live peaceful and quiet lives (I Timothy 2:2). In Romans 13:1, Paul writes to the Roman church that *"there is no authority except that which God has established. The authorities that exist have been established by God."* God allows both good men as well as evil men to move into leadership. It is our responsibility to pray for those who govern over us. God alone is able to turn leaders toward righteousness and wisdom. Proverbs 21:1 states, *"The king's heart is in the hand of the Lord; He directs it like a watercourse wherever He pleases."*

How might we pray for elected officials who serve at various levels of government? I have a bookmark from Pray! Magazine (Issue #13) which lists 30 ways based on Scripture that we can pray for people in authority. The following is an excerpt from that list:

- That they be granted wisdom, knowledge, and understanding (James 1:5).
- That they value and regard the Ten Commandments and the teachings of Christ (Psalm 19:7-11; John 8:31-32).

- That they respect authority and practice accountability (Romans 13:1-7).
- That they be given godly counsel and God-fearing advisors (Proverbs 24:6).
- That they be honest and faithful to spouses and children (Malachi 2:15-16).
- That they be honest in financial, tax, and ethical matters (I Corinthians 6:10; I Timothy 6:6-10).
- That they have thankful and teachable spirits (Romans 1:21).
- That they desire honesty, integrity, and loyalty (Psalm 26; Proverbs 11:3).
- That they have courage to resist manipulation, pressure, and the fear of man (Proverbs 29:25; II Timothy 1:7).
- That they would work to reverse the trends of humanism in our nation (I Chronicles 12:32; Isaiah 59:19).
- That they desire humility and meekness and be willing to serve and cooperate (John 13:14; Titus 3:1-2).
- That they endeavor to restore the sanctity of life, families, divine order, and morality in our nation (Ephesians 5:22-6:4).
- That they be God fearing and recognize that they are accountable to Him for each decision and act (Proverbs 9:10).
- That they be prepared to give account to Almighty God (Hebrews 9:27).

We must remember that our true Kingdom is not of this world, but rather God has empowered His people to share the Gospel to America and a spiritually dying world until *"the kingdom of the world has become the kingdom of our Lord and of His Christ, and He will reign forever and ever."* (Revelation 11:15)

God will use us to do mighty things for Him amid the challenges that we face as individuals and as Teachers Saving Children®. We must stay humble before God and remain true to His calling in our lives. Beginning with each of us, let's all take time in the days and weeks ahead to remember and act on this verse: *"If my people, who are called by my name, will humble themselves and pray and seek my face and turn from their wicked ways, then will I hear from heaven and will forgive their sin and will heal their land."* (II Chronicles 7:14)

## EDUCATIONAL OUTREACH “THE WONDER OF LIFE”

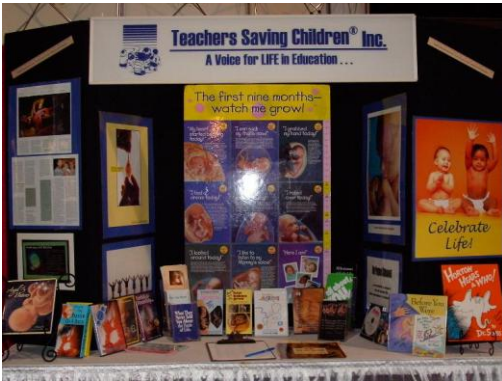
Last Fall, the Teachers Saving Children® Board of Trustees approved expanding our outreach beyond the NEA Expo. With the recent change in broadening our focus to using “The Wonder of Life” exhibit through “Educational Outreach”, Teachers Saving Children® has been and will be enabled to reach more people with the message of LIFE. Though more opportunities may arise in the months and years ahead, currently Teachers Saving Children® has two educational outreach opportunities planned. All monies for these ministry opportunities will be through donations received and specified for Educational Outreach.

The ***first opportunity*** will be the National Education Association Expo, which will be held June 30 – July 2 in Washington DC. The Lord has once again graciously provided, through you our readers and others, the funds needed for the exhibit space rental fee and the miscellaneous fees.

Due to the high volume of individuals visiting our booth, a lot of materials are needed for distribution. We have found over the past several years a high interest, especially among science and health teachers, in the materials we have purchased for our exhibit. These materials include approved brochures which are age-appropriate, positive, colorful, and scientifically accurate. We also include DVDs and books that encourage a respect for human life. We have received about \$400 - \$500 towards the materials to be purchased for distribution. We could use approximately **\$1500** more to purchase the remaining materials needed to reach educators across a wide spectrum of teaching responsibilities.



In addition, we will also need monies for getting our display materials to Washington DC and other Board approved volunteer expenses. We always research for the least expensive means of transportation and other needed provisions. The estimated amount needed for these expenses is **\$400**.

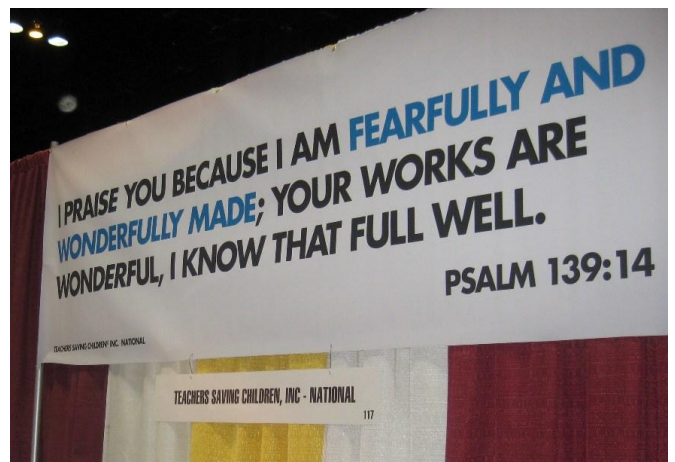


The ***second opportunity*** will be the Students for Life of America Conference to be held on Saturday, January 26, 2013, in Bethesda, Maryland. Though this conference is still 9 months away, there will be upfront expenses when Teachers Saving Children® makes application for exhibit space in the vendor area. The estimated cost for this application is \$700. There will also be expenses to send at least 2 volunteer representatives to the conference. In addition to the exhibit, Teachers Saving Children® plans to request the opportunity to do a workshop/seminar presentation. As soon as the NEA Expo is finished, more detailed plans for Teachers Saving Children® being represented at the Students for Life of America Conference will unfold.

**April 28, 2012** The Teachers Saving Children® National Board of Trustees met in Columbus, Ohio, for their regularly scheduled Spring meeting. The following are highlights of some of the items that were discussed:

1. Election of Officers for the 2012-2013 fiscal year was held. Connie Bancroft will serve as the Executive Director; Gary Winney will serve as the Assistant Executive Director; John Gordon will serve as Secretary; David Kaiser will serve as Treasurer.
2. The Board of Trustees approved a recommendation to make application for an exhibit at the Students for Life of America Conference to be held January 26, 2013.
3. The Board of Trustees accepted the reports of the State Affiliate Chapters.
4. The Board of Trustees approved providing for the 2012-2013 membership year a \$15 coupon for any first-time, new member. The coupon will be available beginning June 1, 2012.

Teachers Saving Children® membership is open to all pro-life/pro-family educators and concerned citizens. Please be advised that, according to the Teachers Saving Children® Constitution & Bylaws, the membership year is from September 1 – August 31, though we do begin renewing memberships in June. Annual dues are \$35.00, with a reduced rate of \$15.00 for students presently enrolled in a college or university undergraduate degree program and also for retired educators currently receiving retiree benefits. Husband and wife may join under the same membership. Contributions and memberships are **NOT** tax deductible.

In June, we will begin accepting new memberships for the 2012-2013 membership year. The Board of Trustees approved providing a **special one-time \$15 coupon, which can be applied toward any first-time membership received during the 2012-13 membership year.** This coupon will be available beginning June 1<sup>st</sup>. Any new memberships received after June 1<sup>st</sup> are good until August 31, 2013.

Renewal membership information will be sent to all current members in late June. **ALL** memberships are handled through the National Office. Each month, State Affiliates receive membership updates and their portion of the dues received.
