A GIFT OF LOVE

During a recent venture to Kettering to pray and carry signs on the abortion mill sidewalk, I witnessed a startling contrast that brought tears to my eyes. Off to my right was the Women's Medical Center, where an abortionist was making money by taking the lives of preborn babies that day; while in front of me, a smiling, petite, eleven-year-old homeschooler, named "Morgan," stood on the sidewalk holding handcrafted blankets intended to warm the bodies of newborn infants. This, her mother told me, is Morgan's ministry. The young girl, her mother added, is always seeking out ways to help those who are in need. She has developed a special interest in pro-life issues, and prays for women to change their mind about terminating their pregnancy.

Morgan came up with, and developed, the idea of making baby blankets for women who decide NOT to go through with their abortions. She also wants to provide blankets for women who need baby items that the mother just cannot afford. And like many pro-life people who walk the sidewalks outside the abortion mill, the girl has a story behind her love of the babies and their moms, as evidenced in the introduction she gives of herself:

"My name is Morgan. I'm a very social 11-year-old who lives in the Dayton area with my fantastic parents. I'm an only child. When I was only a year old, my mother had a miscarriage at 18 weeks. Then, when I turned 2, my mother had yet another miscarriage at 16 weeks. The first baby was a girl, and the second baby was a boy. My mom and dad named the girl Mia, and the boy, Brady.

My mission is to make baby blankets for mothers who cannot afford to buy them or for a mom-to-be who has decided to keep her baby. I pray that ALL pro-choice women and men will re-think what they might be considering or what they might have already done. My hope is that one day abortion will be illegal."

In her own words, Morgan adds a few lighter things about herself...*"I have 3 dogs, 2 birds, 1 fish, and 1 rat," she says. "Yes, you heard right!...a rat! I'm an animal lover! I also have an interest and a talent in art, specifically drawing and painting (water colors)."*

An obvious admirer of her mom, Morgan comments, *"My mother is the most generous, loving, kind person, and she has a great sense of humor. She is my guardian angel on earth. She has encouraged me and has supported this pro-life venture of mine. And if anyone else would like to join me in my mission of making these blankets, I can be reached through my mother's number at 937-901-7254. May God bless and protect all babies of the world who are in danger of being aborted today and in the future!"*

The irony of the scene outside the Women's Medical Center was clear to me. As a sleek automobile pulled up to the door of the abortion mill to drop off a pregnant woman – who would be stumbling out later as childless – the eleven-year-old girl stood on the sidewalk extending her arm with a baby blanket.



HEALTHY RESPECT: SEX EDUCATION THAT INCLUDES CHARACTER AND ABSTINENCE EDUCATION

Can a public school teacher infuse her lessons with a moral compass? As a public school teacher concerned with the sexual health of my students, I wanted to develop a sex education curriculum that would meet state standards for health education while introducing students to the negative consequences of teenage sexual activity. Then I discovered Program Reach's Healthy Respect curriculum (<http://healthrespect.org/>) and found embodied in it a wealth of topics that counter many of the objections I had to the program presently being used in a large number of public junior and senior high schools.

Healthy Respect is a curriculum divided into three levels: Middle School Level (grades 7 & 8), High School Level 1 (grades 9 & 10), and High School Level 2 (Grades 11 & 12). The lessons in this program encourage students to develop their character and their fitness, to explore individual talents and interests, to acquire social and personal management skills, to practice team work, and to make positive choices regarding sex, alcohol, tobacco, violence, and relationships. The lessons help prepare students to be successful in their families, their community and in their future careers. The content of the

program in the lessons for grades 7-11 cover the seven health education standards set forth in the National Health Education Standards: Achieving Health Literacy. The program also meets the US Department of Education Standards for Health Education.

Students are given a pre and post survey which scientifically measures the program's impact. It has been shown to increase student knowledge about the negative consequences of premarital sex (especially those concerning sexually transmitted diseases) while fostering a measurable shift in attitude toward these unhealthy behaviors, a key predictor of their behavior as maturing teenagers. The program presents abstinence education to the students in the context of the short and long term positive impact it will achieve for them throughout their lives by guiding the students to the understanding that abstinence is the healthiest choice they can make for their lives. Students also come to understand that they are more likely to succeed in school and graduate from high school and less likely to end up expelled from school by making healthy choices. Abstinence becomes a positive "good" as the program helps students develop refusal skills to deal effectively with negative peer pressure. In addition, the Healthy Respect program empowers students to develop respect for themselves and others, while increasing their ability to think critically and independently.

As educators, I believe we all need to try to influence our communities to adopt programs that teach our students facts and statistics important for them to know while employing a methodology that helps students adopt desirable and achievable lifetime goals. Healthy Respect students learn that teens (at least up to 18) that are abstinent are twice as likely to graduate from high school, are 60% less likely to be expelled from school, and are 50% less likely to drop out of school. Present these facts to your local board of education and try to get them to adopt the program!
