## RECOMMENDED PRO-LIFE BOOKS

As teachers we know the power of reading. Reading to young children and having children read to us engages them in a way that not only prepares them for success in school, but also can instill positive human qualities we hope for all of us to have. Reading life-affirming, pro-life books is one way to increase a child's self-esteem, compassion, respect for others, and gratitude for the gift of life we are given. Below are a variety of life-affirming/pro-life books from which parents and teachers can select to use in the home and classroom. You can find new and used copies of these books on-line, at book stores, thrift stores and yard sales.

***Angel in the Waters*** by Regina Doman (***Mi Angelito en las Aguas*** – Espanol)  
(In the mother's womb, a tiny baby grows, explores the waters, and talks with the angel who is there with the child.)

***Before You Were Born*** – A Lift-the-Flap Book by Jennifer Davis  
(This is a children's book, exquisitely illustrated, of a baby's prenatal growth. This delightful book is being used in doctors' offices with a very positive response.]

***Donnie Lost in the Cornfield*** by Judy Brunns  
(This book takes a glimpse into the life of a family with a special needs child. For Preschool through 2nd Grade)

***Hattie and Her 43 Cats*** by Judy Brunns  
(A children's book that encourages a respect for people with dementia and Alzheimer's.)

***Justice Loves Babies*** by Darlene and Danielle Wibeto.  
(This book speaks of a little boy's love of his baby sister, while she lives and grows within his mom.)

***Love You Forever*** by Robert Munsch  
(Here's a classic tale of love between a parent and child.)

***I Loved You before You Were Born*** by Anne Bowen  
- A love letter from a loving grandmother who awaits the arrival of her first grandchild.



***Oh, Baby, The Places You'll Go*** by Dr. Seuss  
(This classic children's story shares the intrinsic value of life. Theodor Geisel, known as "Dr. Seuss", was intrigued by research into the development of pre-born babies during pregnancy. The fact that they could hear sounds, and might actually respond to the voices of their parents, was both exciting and mystifying to him. This book was dedicated to all "expecting" parents in the process of getting to know their child and the gift of life.)

***You Are Special*** by Max Lucado  
(In this heartwarming tale, Eli the woodcarver helps Punchinello understand how special he is.)

***Horton Hears a Who*** by Dr. Seuss  
(“A person's a person, no matter how small.” This popular children's book promotes a lesson of dignity for all human life.)

***Now I'm a Big Boy*** by Judy Brunns and ***Now I'm a Big Girl*** by Judy Brunns  
(Each of these books lets a child know how important a little one is, even before the baby is born.)

***The Giving Tree*** by Shel Silverstein  
(This classic story is the story of generosity and selfless love)

***God Gave Us You*** by Lisa Tawn Bergren -  
Children love to hear they are special and loved. This book does a good job of reminding children that they are a special gift from God. This book is for baby to age 2.




*It is no small irony that President Lily Eskelsen Garcia writes about our students as “These babies belonged to all of us...the world is a dangerous place, and...so, NEA fights for racial and social justice and the world we want our babies to live in”, while at the same time, our union, the largest union in the nation, advocates, unapologetically, for abortion on demand, in NEA Resolution I-25 and NBI-56 from last year’s (2019) NEA-RA. Our union supports abortion for any reason, or no reason, at any time during pregnancy, up to and including during birth, at tax-payer expense. Adding to the irony in her words is that abortion disproportionately affects our Black and Brown minority brothers and sisters. Social and racial justice begins in the womb.*
