
### OHIO 2006-2007 MEMBERSHIPS

## **OHIO GUBERNATORIAL CANDIDATE PROFILE**

### Ken Blackwell

Recently, Ohio Secretary of State Ken Blackwell, candidate for governor, opened the door to discussion with four public school educators, all of whom are members of Teachers Saving Children<sup>®</sup>. Here is a brief summary of information shared and the dialogue that occurred on July 27, 2006.

Life Issue – Blackwell

- An outspoken leader in advancing the culture of life
- Says the first function of government is the protection of human life; that the intentional taking of innocent human life is civilly, as well as morally, wrong
- Opposes abortion of all types; says today's advanced medical technology is available to save both the life of the mother and the child

#### **Traditional Family – Blackwell**

- An advocate of the traditional family
- Believes pre-school for a child needs to remain the parents' decision and voluntary, and that making preschool mandatory would undercut the "empowerment" of the family

#### Public Education in Ohio – Blackwell

- Envisions a "3-legged stool" system of services with 1) limited choice programs; 2) more money directed to the classroom; 3) more money to K-12 from the general fund
- Believes limited choice programs open enrollment, alternative schools, community/charter schools, private schools – create competition and invite innovation
- Opposes a universal voucher system but sees a restricted system as a child's way out of a chronically dysfunctional school (referred to a 1992 NEA survey showing that 52% of all public school teachers sent their children to non-public schools at some time or other)
- Advocates that 65 cents rather than 56 cents out of every dollar should go directly to the classroom because student achievement is greatly impacted by resources in the classroom

- Wants to see the covenant the government made with taxpayers 36 years ago, honored – that the income tax would fund public education – breaking the dependency of schools on property taxes
- Wants child-centered funding for K-12 "We have a Constitutional responsibility to K-12. Our present funding system is broken."
- Feels it is possible to increase state funding to public schools from the current 43%, to 55% without a tax increase
- Has studied the strengths and weaknesses of "No Child Left Behind" – points out that a positive is disaggregated testing data, which leads to teaching strategies – "Anything worth doing is worth measuring."

Blackwell concluded his comments by referring to a dialogue he had with a Chinese philosopher about 25 years ago. This philosopher indicated that schools in America have become disconnected from the institutions that traditionally made them work. Those institutions that formerly connected with the schools were family, church, and the workplace. Blackwell explained that we are a society based on limited government because our forefathers believed that we had an inner, moral, spiritual compass that kept things in check. He said it has been since we have taken faith and morality out of the schools that we have had difficulties.

#### **Ted Strickland**

**Editor's Note:** The office of Teachers Saving Children<sup>®</sup> Inc. e-mailed Ted Strickland's campaign office on Sunday evening, October 8<sup>th</sup>, requesting answers to the same 5 questions that were asked of Ken Blackwell. Since no response was received, Teachers Saving Children<sup>®</sup> Inc. sent a follow-up e-mail to Strickland's campaign office on Tuesday evening, October 10<sup>th</sup> and made a follow-up phone call to his campaign office on Wednesday morning, October 11<sup>th</sup>, clearly stating the desire for a response by Wednesday, 4 PM, due to our press deadline. Teachers Saving Children<sup>®</sup> Inc. has received **no reply** from Mr. Strickland.

Congressional Record shows that Strickland voted multiple times in favor of taxpayer-funded abortions and the taxpayer-funded development of an abortion pill (Vote 136, 5/10/06; Vote 216, 5/25/05; Vote 362, 7/15/03; Vote 115, 5/16/01; Vote 373, 7/10/2000; Vote 292, 7/16/98; Vote 173, 6/8/1999; Vote 260, 6/24/1998). In addition, Strickland voted repeatedly against amendments to require more funding for abstinence education programs (Vote 157, 5/1/03; Vote 379, 10/11/01).
