*What Do You Really Believe About  
The Sanctity of Life?*

If you have studied "The Truth Project," the question title of this article is not a new thought to you. "The Truth Project" ([www.thetruthproject.org](http://www.thetruthproject.org)) teaches what a Christian worldview is, and one of the initial questions asked by presenter Dr. Del Tackett is, **"Do you really believe that what you believe is really real?"** You will likely agree that the question is both simple and profound, and does challenge one to examine personal beliefs on a deeper level.

The same question could be asked of all of us who believe in the sanctity of life. There are many people who have a general belief that human life is valuable and should be protected. But how resolute is our belief and how committed are we to protecting human life?

For example, do we truly believe that pre-born infants are indisputably human and that aborting a fetus at any stage of development is morally wrong, and are we willing to defend that belief? Gregory Koukl in an article titled "Fetal Personhood: It's Simple" (Stand To Reason at [www.str.org](http://www.str.org)) points out that in our discussions with pro-choice individuals we may find that they might accept our belief that an unborn infant is a human being - but not a person, in their opinion. And just how can we effectively respond to *that* statement?? Mr. Koukl suggests that we ask them, "What is the difference?" His experience has been that people are unable to explain the difference between the two.

He further states, "The fact is that human beings are persons. . .whether they are in an early stage or a later stage of development. That's what a human is and it remains itself from the beginning to the end. It's very simple. It's not hard. It's not complex."

**I encourage you to take a few minutes to read and ponder the mission statement of Teachers Saving Children® - National:** “...an organization of pro-life teachers and other concerned citizens whose primary purpose is a commitment to establishing a respect for all human life from conception to natural death, especially among professional educators’ organizations” and a quote from Connie Bancroft, our National Executive Director, who stated that “It is only natural that educators, whose mission is to guide and enlighten their students, be concerned with the total well-being of all children. Therefore, support for the intentional abuse or destruction of children at any stage of development contradicts the high ideals of our profession.”

As individuals, it is easy to feel powerless in the face of the opposition that exists to the pro-life cause, even within a profession whose reason for existence is to improve the lives of children. Yet, we must not become “weary in well-doing.” Our cause is worth a lifetime commitment to patience and perseverance!

### *Pace and You*

If you are an educator, you will be especially interested in this information. The **Political Action Committee for Education (PACE)** is the Pennsylvania State Education Association’s (PSEA) political action fund. Money contributed to this fund goes toward lobbying and other political activities of the PSEA and National Education Association (NEA). Local associations ask members to contribute to PACE early in the school year. In contributing, you will be supporting the pro-choice position. If you feel as though you do not want to contribute to PACE because of the NEA-PSEA’s position favoring abortion, **you may simply decline to make a PACE contribution, and also consider submitting a letter of explanation such as the following:**

Dear PSEA/NEA:

I respectfully decline to contribute to PACE due to the NEA/PSEA’s pro-choice position, as evidenced by the NEA policy and past practices stated below:

#### **New Business Item 1990-65:**

*“NEA will oppose any legislation which will erode the status of Roe v. Wade and/or which impedes access of choice. . .”*

#### **Resolution I-16:**

*“NEA supports. . .reproductive freedom.”*

#### **Hospitality Center for Reproductive Freedom:**

- *The NEA headquarters in Washington, D.C., has been a hospitality center for those participating in reproductive freedom protests in the past.*
- *Some NEA state associations have sponsored transportation to such events.*
- *NEA has a history of backing political candidates who are strong opponents of pro-life issues.*

"More than 150,000 adoptions take place each year, but there are still 127,000 children waiting for adoption in the United States in the foster care system as well as infants born to birthmothers not ready to parent. The number of children without loving families is a significant social concern.

Adoption is an important social practice that promotes the well-being of children, families, and society. Adoption positively impacts all involved with the process. It gives birthmothers the assurance that their children will be raised in stable families, gives adoptive parents the joy of parenting, and gives children the opportunity to join a permanent family and grow up in a loving home.

Adoption is also connected to important social issues, such as the sanctity of human life and the definition of family. Adoption upholds the sanctity of human life by providing a positive alternative to abortion for birthmothers who feel unable to parent." ### *Breakaway Invitation*

Richard Armstrong and Edward Watkin tell the story of a biologist's experiment with "processional caterpillars." On the rim of a clay pot that held a plant, he lined them up so that the leader was head-to-tail with the last caterpillar.

The tiny creatures circled the rim of the pot for a full week. Not once did any one of them break away to go over to the plant and eat. Eventually, all the caterpillars died from exhaustion and starvation.

The story is a kind of parable of human behavior. People are reluctant to break away from the rhythmic pattern of daily life. They don't want to be different.

We must break away, however, and be different, even though this is especially difficult in today's world. Being different and thinking independently rather than accepting the "status quo" thinking of the culture is often when we begin to become more aware of the needs of others, and to impact society more creatively.
