Where were you on November 4, 2008?

WHAT YOU NEED TO KNOW ABOUT THE FREEDOM OF CHOICE ACT

As one of the bill's co-sponsors, Senator Barack Obama promised the abortion lobby that this will be the first piece of legislation he will sign into law as President of the United States of America.

The Freedom of Choice Act overturns virtually all federal and state pro-life laws. FOCA would also overturn all restrictions on public funding of abortion and require we, the taxpayers, to pay for elective abortions.

What FOCA does:

- Creates a new federal right to abortion and would repeal the Hyde Amendment, allowing unlimited federal funding for abortion.
- Removes all safeguards ("interferences") currently in place at the state or federal level. These include:
 - Full disclosure to the patient (ultrasound images of the unborn child, details about pain inflicted on the baby, any information about long-term complications for the mother)
 - o Parental notification for minors seeking abortion
 - Waiting periods
 - Restrictions based on fetal viability, allowing for abortion on demand through the ninth month of pregnancy
 - Protections for doctors and nurses who refuse to perform or assist in an abortion
 - Protections for religiously affiliated hospitals, as well as public hospitals, that currently do not perform abortions
 - o Exclusions for abortion coverage from health care plans of federal employees
- Overturns the partial-birth abortion ban, a gruesome lateterm procedure involving the forced extraction of the infant from the mother's womb; insertion of a device to suction the brains from the baby's skull, allowing for the skull to be crushed, facilitating its removal from the birth canal.

The majority of Americans support these common-sense protections. The Freedom of Choice Act is extreme even for many who identify themselves as "Pro-Choice."

Contact your U.S. Senators and Representatives and urge them to oppose the Freedom of Choice Act.

CALIFORNIA CONGRESS

Washington Update – November 21, 2008 Family Research Council

In a surprise ambush yesterday [November 20, 2008], liberal House Democrats unseated longtime chairman Rep. John Dingell (D-Mich.) from his position on the Energy and Commerce Committee and replaced him with Rep. Harry Waxman (D-Calif.). Waxman's coup is alarming to many Democrats, who see the move as a rebuff to the seniority system and an indication that Speaker Nancy Pelosi (D-Calif.) is veering their party "off the cliff." While Dingell is far from pro-life, FRC recognized his willingness to work across the aisle.

Demoting Dingell because he isn't "liberal enough" only divides the Democracts further. Several of the party's rank and file spoke out on Thursday in protest. One member who refused to be identified even said that the leadership was "in orbit; they think it's a California takeover." With health care and sex education firmly in Waxman's control, trouble is already brewing for the pro-family community. You may remember that Waxman was the one who used your taxpayer dollars to launch unsubstantiated attacks on the validity of abstinence education and pregnancy care centers.

As upsetting as the appointment is, FRC was relieved to learn from our sources on the Hill that the leadership will not pursue the Freedom of Choice Act (FOCA) next year. Thanks to FRC Action's ads, more Americans are aware of FOCA's devastating impact on the life movement. Now that our friends are rallying against FOCA, Democrats have decided the issue carries too much political risk. They plan to postpone the legislation until they can chip away at smaller pockets of the values movement.

With Waxman's appointment and today's [November 21, 2008] story that President-elect Obama is delaying the repeal of the "Don't Ask, Don't Tell" policy, it seems the leadership plans to attack life and family by quietly dismantling things that won't make front-page news, like increasing taxpayer funding of abortions, ending conscience protections, and inhibiting free speech....

OHIO ABORTIONS FALL TO LOWEST TOTAL IN 12 YEARS, HEALTH DEPARTMENT REPORTS

Cincinnati, OH (LifeNews.com) - The Ohio health department has released a new report showing the number of abortions in Ohio has reached its lowest total in 12 years. The statistics, which come from 2007, show abortions have declined for another year to 28,921 with almost 94 percent done on in-state residents. As Americans head to the polls today to choose a new President, the Ohio health department noted that the policies of the Bush administration appear to be working in terms of reducing abortions. "The number of total abortions performed in Ohio has seen a decline annually since 2000," it indicated. The new report showed white residents accounted for about 60 percent of abortions in Ohio while black Ohio residents had about 40 percent of the abortions. Women over the age of 25 accounted for nearly half the abortions while women under the age of 20 had just under 20 percent. The report shows abortions have declined consistently among all age groups. Most Ohio abortions are done early in pregnancy, but the report showed at least 14 percent are done after 13 weeks of pregnancy. Most women are unmarried at the time of their abortion.


