# **CONSTANT CONTACT**

After researching and discussing various options to better communicate with our members, the Board of Trustees approved contracting with Constant Contact which is one of the more reputable companies for secure email communication through a "blast" format. #### A TRIBUTE TO JUANITA SATTLER

It was with hesitation and some regret that Juanita Sattler submitted her letter of resignation from the Board of Trustees effective August 31, 2015.

Juanita Sattler has served on the Teachers Saving Children<sup>®</sup> Board of Trustees since October 1998. Having been retired from education for several years, Juanita is realizing that she must now downsize her life as the ordinary is becoming stressful. Her grandson has moved in with her which has been a real blessing for her.

Throughout her life as an educator, Juanita was very active within the local and state associations, having served in various positions including president of the local association. She tried very hard to "improve from the inside." Hanging on the wall over her desk was a saying from Abbey Press: "Education - in spite of all the ideas and all the technology and atoms in the world, it all comes down to shaping one individual at a time." Since retirement, it seems it all comes down to saving one baby at a time as she volunteers with Heartbeat. Juanita has also received numerous awards for her work as a volunteer with Heartbeat and other pro-life organizations.

Having been married over 50 years, her husband, Vern, went home to be with the Lord in July 2010. He was her safety and support net for all activities. They have six grown children, and twenty-six grandchildren, and seven great-grandchildren, all of whom are active in local churches and a variety of community organizations. Her family also supports a variety of educational options - 2 of her children home school, 2 are involved in private education, and 1 has children in public schools. Her family is a smorgasbord of life and love, all supporting one another.

In her letter of resignation Juanita stated that "You [Teachers Saving Children® Board of Trustees] are doing what is acceptable and wonderful in the eyes of our Creator who promised to be with us till the end of time. When God is with you, who can be against you?"

Juanita was presented with a plaque for her seventeen years of service. Thank you, Juanita, for your dedicated years of service to

the Board of Trustees for the cause of life.

#### A TRIBUTE TO DR. JOHN "JACK" WILLKE

Occasionally we read about rare individuals who give up careers to devote themselves to a worthy cause. Dr. John Willke was such a man. He left behind full-time practice as a family physician and dedicated his life to the pro-life movement. Together with his sweet wife Barbara, who also left behind a

successful career as a nurse educator/trainer, Dr. Willke authored books. some of which became the "foundation manuals" for the pro-life movement: Abortion, Questions and Answers: Why Can't We Love Them Both: Handbook on Abortion; Abortion and Slavery. History Repeats; Assisted Suicide & Euthanasia, Past & Present.



Dr. "Jack" Willke and Barbara also put together the famous "Willke Slides," with documented photos and information about human development in utero. The program exposed the various abortion methods used to kill babies during the 1st, 2nd, and 3rd trimesters. The Willkes used the slides in giving thousands of presentations nationally and internationally. Later, local right-to-life groups were trained to use the Willke slides for presentations, too, and they became a fundamental resource for educating and recruiting new members.

The accolades for, and the achievements of, Dr. Jack Willke are many: He hosted a daily radio program carried by hundreds of radio stations; he was interviewed by newspapers, TV, radio, and other media innumerable times; he was past president of the National Right to Life Committee, and the founder, along with wife Barbara, of Cincinnati Right to Life and Ohio Right to Life. And he encouraged our organization, Teachers Saving Children<sup>®</sup>, to be a voice among educators in the pro-life movement. For that encouragement, we are especially grateful.

Jack Willke departed this life February 20, 2015, only 2 months before his 90th birthday. He and his wife, Barbara, had been referred to by those who knew them, as inseparable "soul mates" until she died in April 2013.

Rest in peace, Dr. Willke, where you and Barbara are together again and very likely in the presence of millions of little babies, forsaken by our culture, but loved by Almighty God.

In June 2007, I wrote an article about an outstanding presentation that Dr. Willke conducted for several educators and their guests.

What really touched my heart during his presentation was how he shared story after story about the sanctity of life and how the Lord used even those in the pro-abortion movement to eventually educate the nation about abortion.

One particular story he shared was how the Lord used a proabortion U.S. President's veto power – not once, but twice – to educate a nation about partial-birth abortion. It was during President Clinton's term that Congress first began debating and approving the proposed Partial Birth Abortion Ban. Congress passed a bill banning the grisly procedure two times. Knowing that there were not enough votes to override President Clinton's veto, Congress continued to debate and pass this legislation. They could have shelved the bill; instead they pressed on. During those months of debate, Americans became educated on what partial birth abortion entails. The effect of that education eventually impacted national leaders to pass the Partial Birth Abortion Ban a third time and President Bush signing the bill into law. Even the U.S. Supreme Court upheld the law.

After listening carefully to Dr. Willke share this story, I came to the conclusion that we often look only at the negative that is taking place. Dr. Willke helped me to see the debate from different perspective.



He helped me to see how God used this lengthy debate and process through the Legislative, Executive, and Judicial branches to educate a nation about a horrible abortion process – and, most importantly, about life.

Dr. & Mrs. Willke were strong supporters of Teachers Saving Children® and really encouraged our board during the early years of our organization. He also, along with his precious wife Barbara, impacted many lives, including mine. He encouraged every one of us with the message of hope.

**April 25, 2015** The Teachers Saving Children<sup>®</sup> National Board of Trustees met in Columbus Ohio, for their regularly scheduled Spring meeting. The following are highlights of some of the items that were discussed:

- 1. Election of Officers for the 2015-2016 fiscal year was held. Connie Bancroft will serve as the Executive Director; John Saxe will serve as the Assistant Executive Director; John Gordon will serve as Secretary; Gary Winney will serve as Treasurer.
- 2. The Board of Trustees approved a recommendation to make application for an exhibit at the NEA Expo 2016 in Washington DC. By making this decision now, there will be a savings in the costs as well as the opportunity to select an exhibit location that will allow Teachers Saving Children® to maximize their visibility.
